1. Introduction

Cambodia's natural forests, which have experienced significant declines in recent decades, have been under the management of the state and, until recently, there has been limited recognition and encouragement associated with the establishment of private forest plantations. This situation has discouraged the private sector, as well as those small-scale farmers who, except for their concerns about ownership claims and user rights, might otherwise have invested in plantation development. There is increasing recognition now of the constraints associated with excessive reliance on funding from the government for reforestation and forest restoration activities, however, that limits the application of those activities to a relatively small proportion of the country's degraded forestlands. Efforts to integrate an interrelated approach into forest landscape restoration activities that would arouse the private sector, small-scale farmers, and financial institutions – the latter of which have heretofore lacked collateral assurances from the government for loan programs - to invest in forest plantations – are increasing.

The principal elements of that approach were recently espoused when the country's first Declaration on Private Forests with the avowed aims at promoting public-private-farmer partnerships for establishing small- and medium-scale forest plantations and increasing forest cover throughout the country was promulgated. The implementation of that declaration requires an effective enabling environment, however, which would include the establishment of practical guidelines and incentives for confirming tenure and registering small-scale private forest plantations, accompanied by extensive stakeholder consultations and awareness raising campaigns, as well as the piloting of private small- and medium-scale forest plantations.

It is in recognition of these developments that the project for 'The Registration of Small-Scale Private Forest Plantations' is proposed. It was developed to coincide with the assorted factors of success that accompanied the favorable phasing associated with the recent promulgation of the government's Declaration on Private Forests. It will facilitate the development of the guidelines and incentives that will define the conditions required for confirming tenure and registering small-scale forest plantations and raising public awareness of those conditions among potential private sector and small-scale farmers investing in forest plantations in Cambodia.

One of the project outcomes is institutionalizing the enabling environment and the distribution of *D. cochinchinensis* seedlings, which would be an essential component of efforts to ensure the sustainable and legal domestic trade in *D. cochinchinensis*, and which might, with the continued expansion of small-scale plantations, be able to be traded in international markets. To favor this, the guideline on private forest registration has been developed, and constructive feedbacks on land tenures and incentives have been collected through a national consultation held on 26-27 November 2020.

2. Objectives

The development of guidelines and incentives for the registration of private forest plantations has been initiated since mid-2019. The drafted guidelines have been reviewed and discussed internally among project team members and officials of the Department of Forest Plantations and Private Forest Development. The Extension and Consultation Workshop was organized with the following objectives of:

- Improving understating of Forestry Administration officials, policy makers and representatives of private sector with investment in forest plantations and wood processing on Private Forest Rules.
- Sharing knowledge, experiences, technologies, best practices associated with investment in private forest plantations and wood-based processing enterprises.

- Collecting data and statistics related to forest plantations, number of trees planted, tree species and distribution of seedlings in each provincial Cantonments of the Forestry Administration.
- Seeking inputs and common understating on the drafted Guidelines and Incentives for the Registration of Private forest Plantations.

3. Participants

This 2-day workshop was organized by the Forestry Administration with joint financial support of CITES and Asian Forest Cooperation Organization (AFoCO). The workshop was actively attended by 125 participants (10 females) who were representatives from:

- National Assembly
- Deputy General directors of Forestry Administration
- Provincial Cantonments of the Forestry Administration
- Divisions of the Forestry Administration
- Triages of the forestry Administration
- Line Departments of the Forestry Administration
- Royal University of Agriculture
- Prekleap National Agricultural Institution
- Private sector with investment in forest plantations and wood processing

A full list of participants is presented in Annex 2.

4. Arrangements

In line with the objectives of the workshop, it was composed of presentation sessions aimed at sharing essential information and group discussion sessions where participants actively engaged in narrowing down to the guidelines. The detailed workshop schedule is available in Annex 1.

The first day was started with an overview of presentations on policy framework, progress of the implementation of private forest registration projects, demand and wood supplies and presentations by private sector related to investment in forest plantations in Cambodia. Questions and discussion were prepared to encourage participants especially private sector to be in connections with a new, less-widely disseminated circular on Private Forest Rules issued by MAFF in 2017.

In the second day, total of four parallel working groups was formed and the discussion organized under four questions related to the drafted guidelines.

- 1) What need to be improved related to processes and procedures developed to establish and register family, small, medium and large scale of private forest plantations in Cambodia?
- 2) What requirements and criteria of land ownership should be used to register family, small, medium and large scale of private forest plantations in Cambodia?
- 3) What other aspects or cases do you think should be used to establish and register private forest plantations in Cambodia?
- 4) What comments and recommendations do you have related to chapter1, 3, 4 and 5 of the drafted guidelines?

Each group discussion was guided by dedicated facilitators with step by step instructions and real time support from guideline expert. To build capacity and relationship of participants each group discussion also include project team members. Each group discussion selected one representative to present the results of their group discussion.

5. Summary of the Workshop

5.1 Welcome addresses at the Opening Sessions

Ms Lim Sopheap, Deputy Director of the Department of Forest Plantations and Private Forest Development, on behalf of Dr. Ly Meng Seang, Director of the Department of Forest Plantations and Private Forest Development welcome all participants attending this workshop on Extension on Private Forest Rules and Guidelines for the Registration of Private Forest Plantations in Cambodia organized by the Forestry Administration in partnership with CITES Tree Species Program and AFoCO Secretariat. She highlighted the objective of this workshop is to collect important inputs, best knowledge and experiences shared by all participants to improve the drafted guidelines.

She stressed that the Declaration on Private Forest Rules was promulgated by the Ministry of Agriculture, Forestry and Fisheries in 2017 in line with Forestry Law 2002 and National Forest Program 2010-2029. To complement effective implementation of the Private Forest Rules and to facilitate the registration of private forest plantations, the development of the Guidelines for the Registration of Private Forest Plantations was initiated in 2019 and completed in late 2020.

H.E Cheam Pe Ah, a Parliamentarian of the National Assembly gave his remark by highlighting Forestry Law adopted in 2002 by the National Assembly. The Law has been implemented for nearly 18 years which should be reviewed and amended to respond to current situation. He preferred using a term of private plantations to private forests. He praised a number of Forestry Administration officials who own private nurseries and produce seedlings for sales. He personally purchased seedlings produced by Forestry Administration officials to distribute to local communities and public institutions in his constituency. He also owns plantations of *Dalbergia conchinchinensis* on his private land.

Oknha Dr. Nang Sothy, General Manager of THY HOLDING GROUP CO., LTD, was very happy to be with all participants. He thanked the Forestry Administration for inviting him to this important event. He extended full support for the development of the Guidelines for the Registration of Private Forest Plantations. He stressed that one of his company investment is agarwood plantations in coastal provinces. He asked the Forestry Administration and CITES Management Authority to provide favorable conditions and necessary permits to export agarwood and agarwood oil.

Mr. Chheang Dany, Deputy Director General of the Forestry Administration in the name of H.E Dr. Keo Omaliss, Delegate of the Royal Government of Cambodia in charge as Head of Forestry Administration

welcomed all participants attending this workshop organized by the Forestry Administration in partnership with AFoCO Secretariat and CITES Tree Species Program.

He expressed his support for the development of the Guidelines for the Registration of Private Forest Plantations in Cambodia as part of FA forest sector reform which promotes effective participation of commercial forest planting by private sector and provide rapid and efficient administrative service to the publics and private sector in harvesting, transporting and collecting their private forest plantations.

Finally he expressed gratitude to the Government of the Republic of Korea through AFoCO Secretariat and European Union through CITES Secretariat for financial support for the implementation of private forest registration projects. He requested all participants in this workshop to study thoroughly the full text of the Guidelines for the Registration of Private Forest Plantations and provide best experiences, good comments and constructive recommendations to ensure that the guidelines is consistent with relevant policies, indicators and other measures to contribute to the benefits of sustainable agriculture in the long run.

5.2 Policy framework and incentives related to forest plantations in Cambodia

Mr. Kim Sobon, in the name of Dr. Ly Meang Seng, Director of the Department of Forest Plantations and Private Forest Development, summarized regulatory and policy framework and incentives related to forest plantations in Cambodia. The regulatory and policy framework include Forestry Law (2002), Rectangular Strategy Phase III 2018-2023, National Strategic Development Plan 2018-2023, National Forest Program 2010-2029, Forest Development Strategic Plan 2017-2030 and policy incentives for development of plantations namely on Circular on Permit to Plant Trees on Degraded Forestland as Private Public Partnership issued by the Council of Ministers in 2017 and a reduction of 50% of the total obligatory export fees for export of wood products from forest plantation, and a 100% exemption of export fees for furniture and final processed products produced from forest plantation, which was issued by the Council of Ministers in 2019.

5.3 Progresses towards implementation of FA-CITES and FA-AFoCO Projects

Mr. Hort Sothea, Deputy Director of the Department of Wildlife and Biodiversity introduced objectives, expected outputs and target locations of both projects namely Integrating the Development of Guidelines and Incentives for Piloting the Establishment of Small-scale Private *Dalbergia* Plantations with the Determination of a Non-detriment Findings Report in Preah Vihear Province in Cambodia funded by European Union through CITES Secretariat and The Registration of Small-Scale Private Forest Plantations funded by the Republic of Korea through AFoCO Secretariat. The Majority of achievements of the both projects include:

- Completion of the developmen of the drafted guidelines for the registration of private forest plantations including practical procedures, application forms, logbook and registration certficiate.
- Distribution of 79,000 seedlings of fruit trees and indigenous trees to local communities and public institutions in Kampong Siem, Stung Trang and Chamka Leu districts, Kampong Cham province and completion of the distribution of 52,500 seedlings of *D. Cochinchinensis* to local communiies and public institutions in Choam Ksant district, Preah Vihear province.
- Completion of the preparation of inventory report based on the collection of information on the distribution, structure, and individual and/or stand size, stocking levels, diameter class distributions of populations of *D. cochinchinensis* and *D. oliveri* in the Choam Ksant district, and report on taxonomy, biology, ecology, habitat and dynamics of both species.

5.4 Investment in Acacia Plantations, Camagra Company.

Mr. Sem Sinuon, Operation Manager, provided an overview of the investment of the company in acacia plantations. The company has three locations of land for the investment of plantations with the total area of 8,035ha in three provinces-Koh Kong (4095ha), Sihanouk Ville (1400ha) and Kampot (2540ha).

Acacia is its main plantations. He provided the process of the production of seedlings and planting, maintenance as well as compost fertilizer production. The plantations of Acacia are the sources of raw materials used to produce plywood, floor and furniture and production of chip wood for renewable energy. In the future, the company plan to produce eco-friendly charcoal for domestic consumption and export.

5.5 Investment in Teak

Mr. Oumri Gonen, Representative of Teak Farm company summarized the development of teak Farm using modern technology in Aural district, Kampong Speu province to promote the growth of teak employing reasonable fertilizers and modern irrigation system. The company developed infrastructure, prepare final bed, extend water source development and planting operation. Planting production include highest quality clone, detailed methodology and intensive monitoring. The results of employment of modern and reasonable technologies suggested that with age of 18 months, a teak could reach 8m tall and 12cm in DBH. The company requested the Forestry Administration registers company's teak plantations to promote investment. In the future, the company will expand its plantations based on technologies, experiences and best practice.

5.6 Timber demand and supplies in Cambodia

Mr. Chea Nareth, an office Chief of the Department of Forest Industry and International Cooperation gave a presentation on timber demand and supplies in Cambodia. He shared statistics of wood processing factories in Cambodia in the last five years from 2016-2020. There are 42 wood processing factories in 2020 down from 65 in 2016. The sources of timber supplies came from economic land concession, social land concession, forest plantations and imports of timber. He shared the assessment of demand for sawn wood for the last 10 years 2009-2018 for the construction of houses, hotels and guesthouses ranging from 289,304.376m³ in 2009 to 358,939.492m³ in 2018. Similarly the prediction of supplies for sawn wood for next 10 years 2019-2030 for house construction in Kratie province ranges from 11,636.588m³ in 2019 to 14,562.531m³ in 2030. He also provided total figure of imported wood of 6,861m³ in the last five years 2016-2020.

5.7 Investment in plantations of *Aquilaria Crassna*

Okhna Dr. Nang Sothy is the General Manager of THY HOLDING GROUP CO., LTD and 8S AGRO-INDUSTRIES CO., LTD. He provided an overview of the distribution of agarwood plantations in Koh Kong, Kampong Soam, Kampot, Kep, Pursat, Pailin, Siem Reap and Kampong Cham provinces. His company has made investment in agarwood and currently own 1,000,000 agarwood trees in Kampot and Koh Kong provinces with a total area of 400ha. The company owns two agarwood oil processing factories in Kampot and Sihanouk Ville provinces with the total capacity of 85 extracted oil tanks.

Finally he requested the government of Cambodia to provide incentives to families, farmers and companies which are willing to make investment in plantations of agarwood in the form of concession loans or loans with low interest rate to promote the investment in agarwood plantations.

5.8 *D. cochinchinensis* plantations and Green investment-challenges and opportunities

Mr. Chheang Dany, Deputy Director General of the Forestry Administration, presented challenges and opportunities for the investment in the planting of *D. cochinchinensis* in Cambodia. He introduced an estimated population of 5.75 million of *D. cochinchinensis* standing trees propagated in Cambodia with age 2-10 years and 2-15 meters in high and provided overview of the analysis of cost and benefits of the investment in *D. cochinchinensis*. He highlighted investment opportunities for *D. cochinchinensis* with high demand for both regional and international markets with high price. The challenges to the investment is that low production capacity, legal permit, certificate of origin and CITES permit.

5.9 Investment in Eucalyptus, Paper Tree Investment (Cambodia) Co., Ltd

Mr. Um Sophorn, Representative of the company. The company was established in 2009 in Bantey Meanchey province. In 2012 the company started to produce seedlings of eucalyptus and has distributed and sell the seedlings to local communities and promised to buy back eucalyptus planted by the communities. The company owns private land of 1,721 ha in three provinces-Bantambong, Pailin and Bantey Meanchey. The company has planted approximately 2,344,564 seedlings of eucalyptus since 2017 in the three provinces and continue to plant on their private land. The company established chip producing factory based in Bantey Meanchey province close to the border with Thailand. The chip produced will be exported to Paper Mill in Thailand. He also highlighted challenges which include lack of land, or concession land for planting of eucalyptus and skill workers. He stressed that his company need more land along the border with Thailand in three provinces to plant eucalyptus.

5.10 Assessment of growth patterns of forest plantations in Cambodia-Acacia, eucalyptus

Mr. Kim Sobon shared case studies of the assessment of pattern growth of forest plantations in Cambodia conducted by OJI Paper Co.Ltd, in Kampong Chhnange province, especially mean annual increment (MAI) and current annual increment (CAI). These two parameters influent pattern growth of forest plantations. The first case study involve two species of fast growing trees namely Acacia hybrid and eucalyptus K7 which apply fertilizers NPK+trace element with three treatments-control, standard and double. The result of the study indicated that standard treatment of both species-Acacia hybrid and eucalyptus K7 with MAI=22.6m³/ha/year and 13.6m³/ha/year, respectively. The study concluded that pattern growth of the two species reached maximum growth at the age of fifth year and then the growth rate slows down. The optimal harvesting period of plantations of the two species is at the fifth year.

5.11. Private Forest Rules

Mr. Chornng Tol, Chief of Private Forest Plantation Office, Department of Forest Plantations and Private Forest Development summarized the Declaration on Private Forest Rules in Cambodia issued by the Ministry of Agriculture, Forestry and Fisheries in 2017. The Declaration consists of five chapters:

Chapter 1	General provision
Chapter 2	Registration of Private Forest Plantations
Chapter 3	Harvesting and Exploitation of Private Forest Plantations
Chapter 4	Inter Provision and
Chapter 5	Final Provision

The Declaration is intended to Encourage an individual and private entities to participate in the planting of trees on their private land to establish private forest plantations and forest plantation cover which lead to increase in supply of timber and non-timber forest products for processing, domestic consumption and exports; There are four classifications of private forest plantations stated in the Declaration: 1) household private forest of less than 10 ha; 2) small-scale private forest of between 10 ha to 100 ha; 3) medium-scale private forest of more than 100 ha to 1,000 ha; and4) large-scale private forest of more than 1,000 ha.

SUMMARY OF DAY 2

5.12. Drafted Guidelines and Incentives for the Registration of Private Forest Plantations

Mr. Kim Sobon provided an overview of the drafted guidelines and incentives for the registration of private forest plantations in Cambodia. This guidelines will complement the implementation of Private Forest Rules issued by the Ministry of Agriculture, Forestry and Fisheries in 2017. The guidelines provide guidance of how owners of private forest plantations or private forest operators register their private forest plantations, what benefits and incentives they gain from the registration of their private forest plantations.

The most importance of the guidelines is the chapter 2 which set the practical procedures for the registration of private forest plantations based on four classifications of private forest plantations in Cambodia. There are three steps for the registration of private forest plantations-step1) Submit application form; step2) review and evaluation and step3) issuance of registration certificate. Application form, evaluation form, registration certificate have been developed to facilitate owners of plantations and Forestry Administration officials to be used and filled.

 - Chapter 3, 4 and 5 should be integrated into one chapter (chapter 3: management of private forest plantations).
 - Add one more chapter: Monitoring and Evaluation.
 - Definition of private forest should be consistent with the definition stated in Forestry Law deleting ward outside protection forests.
 - Registration of private forest plantations should be conducted in two forms-1) as plantations and 2) as number of trees planted because trees planted along public roads, surrounding pagodas and public space cannot be registered as plantations.

6. Conclusion

The workshop was successfully organized with active participation and discussion on the Guidelines for the Registration of Private Forest Plantations in Cambodia. The workshop in addition to improving knowledge of participants, marked importance of the development of the Guideline as we see an increase in investment in forest plantations in the form of private forest plantations and private-public partnership. This guidelines when approved will provide clear roadmap and procedures for the registration of private forest plantations and will complement the implementation of Private Forest Rules.

The inputs gained from this workshop following intensive discussion and consultations among participants especially inputs from private sector will be used to improve the drafted guidelines especially the process and procedures ranging from submission of application to the issuance of registration certificate. The process are simplified to accommodate to local context.

There are still contentious issues related to private land especially private land used to plant trees. However, currently many land plots in Cambodia have not been registered or has no land titles that may not be encouraged by the process of the registration of private forest plantations. Although the workshop set clear criteria and conditions for the registration of private forest plantations, high level decision on the land issues are necessary to ensure that the process and procedures for the registration of private forest plantations will go smoothly.

The guideline is limited to the registration of private forest plantations in Cambodia. However, the workshop has suggested that the guidelines should also cover and expand the registration to not only private forest plantations but also to forest plantations planted on economic land concession, public

private partnership plantations on forest state land and forest plantations under leasing contract of forest state land. In this context, Private Forest Rules issued in 2017 should be amended to cover the registration of forest plantations on forest state land and economic land concession.

7. Recommendations

- Private Forest Rules issued in 2017 by the Ministry of Agriculture, Forestry and Fisheries should be amended to expand the registration of forest plantations on economic land concession, public-private partnership plantations on state land and forest plantations on state land under leasing contract to facilitate the export of processed-wood products originated from forest plantations.
- The registration of private forest plantations should be conducted in two forms: 1) in the form of plantations and 2) in the form of number of trees.
- Private forest plantations should be reclassified from four to three categories (family and small scale of private forest plantations should be integrated into one category to simplify the submission of application form and the issuance of registration certificate).
- Provincial Departments of Agriculture, Forestry and Fisheries should be authorised to issue registration certificate for family and small scale of private forest plantations (It is noted that application form for registration of family and small scale private forest plantations has to be submitted to provincial Departments of Agriculture, Forestry and Fisheries in each province).
- One more chapter-monitoring mechanism and incentives should be added to the guidelines while chapter 1 related to definition should be revised to introduction. Policies, strategies and laws and regulations should be separately described in the guidelines.
- The registration of private forest plantations should not be conducted associated with national security zone, world heritage sites, conflicting areas and areas under court investigation except there is permission by the government.
